CIG MEETING 1.7.08



#### CAMU Application Status

- Draft Application to be submitted by FMC to the Agencies in January 2008. Review draft application with CIG, near neighbors, and Royalton/Middleport officials.
- ◆ Anticipate comments back from Agencies by February/March 2008.
- ♠ Revise draft application based on Agencies comments and finalize for Agencies' public meeting/public comment period in April/May 2008.

#### **Grant Applications Update**

- ◆ Awaiting response from Restore NY application submitted in September 2007.
- ◆ Submitted Environmental Protection Fund application in December 2007. Village wishes to obtain funding in order to draft and implement building design standards for buildings located in the Village Central Business District (CBD).
- ◆ Started the process for a grant application under the Main Street Program for various streetscape enhancements and revitalization projects in the CBD (Due March 2008).

### Waste Water Treatment Plant Upgrades

- All major equipment has been installed as outlined in the Engineering documents. Other minor equipment/instrumentation to be completed early 2008.
- The control system is being installed and completion of the installation is targeted for January 2008.

## Phase 2 North Railroad Property ICM

- Work to install an engineered cover over a section of the FMC-owned railroad property is scheduled for spring 2008 (weather dependent) and will extend into the summer months.
- ♦ Access is still being negotiated with utility company.

## On Plant Site - Vapor Intrusion Study

- Working with the Agencies on developing a vapor intrusion investigation study for the plant site. (Study at Roy-Hart previously completed and found vapor intrusion is not evident.)
- FMC is in the process of responding to the Agencies' comments.

## 2007 Early Actions Project Summary

- P-Block Properties completed by October 31, 2007, Wooded Property completed on November 16, and Culvert 105 properties were completed on November 30, 2007.
- ◆ Fence installed on Wooded Property; other trees may be planted there in spring 2008.
- ◆ Arborvitaes are being installed on the Wooded Property along the southern property boundary in lieu of a small earthen berm.
- ◆ FMC monitoring properties during winter months until landscaping, lawns, etc.are established.
- ◆ Inspections of completed areas and repairs/touch-up as necessary, street repairs; lawn fertilization/watering program; monitoring of MH-N9 and Wooded Property will be done in early 2008.
- Landscaping, pool and deck installations to be scheduled by remaining individual property owners next spring.
- ◆ Trees to be installed spring 2008 on Margaret Droman Park.
- FMC to submit construction report for Agencies review and approval.
- ◆ FMC expects the Agencies will send letters to the affected property owners stating that the clean-up is complete.

# Phytoremediation Pilot Study Update

- Submitted draft Work Plan to the Agencies in December 2007.
- ◆ FMC is waiting for Agencies' comment and approval of the Work Plan.
- Plant order has been placed with various vendors.
- ◆ Cornell University is to perform bench-scale testing to identify possible amendments that may improve the arsenic uptake from the test soils in the various plants that will be used.
- ◆ FMC anticipates a spring 2008 start date.
